5.2 VICE PRESIDENT'S REPORT

Vice President Christine (Christi) Scarrow reported.

- Improved capacity for identifying and resolving issues.
- Standardized documentation and improved tracking for disciplinary cases.
- Supported timely and fair resolutions through board collaboration.
- Promoted transparency and education around resolution pathways.
- Encouraged committee participation and future improvements, including further implementation of Safety Committee recommendations.

5.3 TREASURER'S REPORT

Treasurer Graeme Lake reported.

- The MGHL is in a strong financial position, with a reserve fund exceeding \$140,000 and a healthy operating balance.
- The League's ice bill approached \$750,000 for the season, underscoring the scale of operations.
- Referee expenses totaled nearly \$100,000.
- Tournaments and social events, such as the parent gala, were profitable and helped fund other initiatives.
- The Hurricane Assist Fund supported four players in need, providing approximately \$1,400 in subsidies.
- It was also noted that Graeme will be stepping down as Treasurer, with the League transitioning to QuickBooks for improved financial oversight.

5.4 REGISTRAR'S REPORT

Registrar Erin Cassan reported.

- The League registered over 850 players and 350 bench staff.
- One of the biggest challenges of the season was the rollout of the Vulnerable Sector Check (VSC) requirement from Hockey Canada and the OHF.
 - Despite administrative difficulties, all requirements were met.
- Maintained regular contact with OWHA throughout the season to ensure team compliance.

5.5 EPP DIRECTOR'S REPORT

EPP Director Darcy Breakey reported.

- Positive year for the EPP.
- The annual "Pink in the Rink" fundraiser raised \$1,200.
- The first-ever EPP Retreat at Tecasy Ranch was held successfully, fostering player development and bonding.

- The Coaches Site subscription was renewed, providing resources to all MGHL coaches.
- MGHL players represented Canada and Japan at international events.
- EPP teams earned medals at OWHA Championships and various showcases.
- Plans for 2025–26 include expanding outreach through virtual info sessions and continuing to promote MGHL as a high-performance hockey destination.

5.6 REP DIRECTOR'S REPORT

Rep Director Charles Eddie reported.

- 2024–25 season saw 24 Rep Teams, with 11 qualifying for league championships, 12 for consolation, and 14 for provincials—marking record highs across all categories.
- Looking ahead to 2025–26, an increase to 27 Rep Teams and welcomed 7 new coaches. 90+ players will graduate from the 2008 birth year.
- Charles announced that he would be stepping down after this season and thanked the board and community for their support.

5.7 HOUSE LEAGUE DIRECTOR'S REPORT

House League Director Scott Forsyth reported.

- Strong season with over 350 players and stable U7 enrollment (~100).
- Transitioned to paid development skates to improve attendance and value.
- Replenished House League goalie equipment (24 new sets purchased and 90% used).
- Organized participation in Caledon loop and Queen of the House Tournament.
- Identified scheduling challenges due to weather and Iceland Arena closures.
- Recognized Adam Pratt with the House League Volunteer of the Year Award.
- Plans for next season include earlier jersey ordering, expanded goalie clinics, and continued / improved PWHL association initiatives.

5.8 DEVELOPMENT DIRECTOR'S REPORT

Development Director Stacey Marnoch reported.

- Development portfolio had expanded significantly this year.
- Introduced age-specific development guides and video libraries for coaches.
- Prioritized skating development, particularly for younger players.
- Advocated for increased female coach recruitment, noting MGHL leads OWHA in female coach participation.
- Identified a goal to establish MGHL's reputation as a center of excellence in hockey development.

5.9 SPONSORSHIP DIRECTOR'S REPORT

Brad Saunders on behalf of Pat Ceci reported.

- The Parent Gala and Rep Awards Night saw record turnout.
- Volunteers enabled rapid event setup/tear-down, with positive feedback from the venue.
- MGHL awarded two U18 scholarships with help from Jared Gardner.
- A booth at an August event (hot air balloon festival) will be used for outreach.
- Sponsors like Scotiabank, Tim Hortons, and Pizzaville played key roles in supporting league-wide initiatives.

5.10 TOURNAMENT DIRECTOR'S REPORT

Tournament Director Brennan Mercer reported.

- The Winter Classic hosted 170 games and 12 divisions.
- The AA Showcase hosted 103 games and 40 teams.
- MGHL teams won in both tournaments.
- A new March 2026 House League tournament has been proposed (pending OWSHA approval).
- GGTS (Gina Gibson) will continue as tournament administrator.

5.11 EQUIPMENT DIRECTOR'S REPORT

Equipment Director Neil Coreschi reported.

- Dukes successfully outfitted 25 Rep and 24 House League teams.
- Third jersey was introduced (13 teams signed up for 2025–26).
- 320 members now participate in the MGHL Facebook equipment exchange.
- A new line of branded items (e.g. hats) will be launched via Dukes.
- September equipment exchange event is confirmed.

5.12 COMMUNICATION DIRECTOR'S REPORT

Communication Director Christina Forsyth reported.

- The MGHL website saw a 9% increase in page views; most visited pages were homepage, team listings, and schedules.
- Email newsletter subscriptions rose 11% to 1,400, but open rates dropped to 40% (from 64%) due to external email provider spam filters.
 - Please mark MGHL communications as NOT spam/junk and add typical MGHL emails to trusted sender and contact lists to ensure continued receipt of important League information.
- Instagram continues to be the League's most engaged social channel.
- Worked on documentation, templates, certificates for Rep awards, and special initiatives.
- Reinforced the importance of brand consistency and respectful social media use.

8.2 ASSEMBLY QUESTION 2	<p>Phillip Li Asked</p> <p>I would like to know how the league will meet its 80% resident targets. As our ice rates are obviously subsidized I'm concerned when teams at the A and below levels are more than 65% non residents. Why are teams with more than 65% non residents rewarded with cheap rates and not held accountable at all to prioritizing residents and existing MGHL players. While imports are necessary, it's crazy when some teams at the A level and below are essentially full of imports.</p>	<p>Christine Scarrow Responded (Live)</p> <p>Christine acknowledged the concern raised regarding the high proportion of non-resident players on certain teams, particularly at the A and below levels, and the impact that has on subsidized ice rates.</p> <p>She responded by affirming that this is an important issue and that the board has actively discussed how to better align team composition with the 80% residency target set by the City of Mississauga.</p> <p>Christi presented that the MGHL is taking the following steps:</p> <ul style="list-style-type: none">• The League is focusing on promoting the MGHL more effectively within Mississauga through enhanced marketing and communications.• There will be specific efforts to attract and retain Mississauga-based players by showcasing the benefits of playing within their home city.• She emphasized that meeting the 80% residency target is not something that can be achieved overnight. However, the League is committed to making incremental improvements year over year to bring team compositions closer to that goal.• Christi noted that attracting talent from outside the city is a sign of a strong and desirable organization, and while imports are part of Rep-level play, the League is mindful of striking a better balance moving forward.
